The 2026 National PACE Association (NPA) Spring Policy Forum will be held March 23-24 at the Mayflower Hotel in Washington, DC. 2026 NPA Spring Policy Forum Exhibit Information

Exhibitors will have the opportunity to network with staff from operational and prospective PACE providers and to share information about their products and services in a tabletop exhibit format. NPA is committed to promoting exhibit hours to attendees and has allotted in the forum schedule approximately **3.5** hours of designated exhibit time. Exhibits, as well as all continental breakfasts and breaks, will be located in the historic Chinese Ballroom and the Promenade Foyer, which is the main thoroughfare of the hotel and adjacent to NPA registration. The ballroom is beautifully adorned with hand-painted ceilings and renowned for entertaining dignitaries from around the world.

In addition to having the opportunity to maximize awareness of their products and services during exhibit hall hours, exhibitors will receive the following benefits:

- » one complimentary registration to the forum;
- » a copy of the advance registration list two weeks prior to the forum and the final registration list following the conclusion of the forum for valuable promotion and follow-up;

Location

Exhibits will be located exclusively in the Chinese Ballroom and Promenade Foyer, the main thoroughfare of the forum, including NPA registration and the general session meeting room at the [Mayflower Hotel](#), located at 1127 Connecticut Avenue NW, Washington, DC, for the duration of the exhibit period.

Exhibit Space

Each space will consist of one skirted 6-foot table, two chairs and a wastebasket.

Vendors can select their booth space in the online exhibit portal. NPA reserves the right to alter the floor plan and make the final determination of all space assignments in the best interests of the event.

All exhibits must remain within the confines of their assigned 6-foot table exhibit space. Exhibitors may not alter the location or orientation of their assigned space or erect signs or any other display that obstructs the view or disadvantageously affects the display of other exhibitors.

No booths or other set-up options are available due to limited space.

Changes to Application

It is the exhibitor's responsibility to inform NPA of any changes to the information indicated on their exhibitor application, including the addition of or changes to exhibit staff. Changes to the exhibit application should be made in writing to [Sue Hagler](#) with as much notice as possible to maximize the ability of NPA to make accommodations.

Exhibitor Agreement

"Exhibitor" refers to the organization or person that requested and has been granted exhibit space rental and its employees, contractors, agents and representatives. Exhibitor agrees to the terms included in this Agreement, in addition to any others outlined in the Prospectus or NPA Exhibitor Service Kit, communicated by NPA, or adopted by the event facility (collectively, "Terms"). NPA reserves the right to reject a request for exhibit space rental in its sole discretion.



Exhibit Space Selection

NPA utilizes an online exhibit portal that allows vendors to select both their booth location and sponsorship items. Each vendor will receive an email invitation from NPA Conferences containing a direct link to the portal, making it easy to choose their preferred options and manage their participation. Booth selections will be held for 20 minutes if not purchased upon selection. After 20 minutes, the booth will be released for other vendors to purchase. Exhibitor is not permitted to assign, sublet, or share any part of their assigned exhibit space with another business or entity (including affiliates, subsidiaries or parents) without prior written consent of NPA.

Payment and Cancellation Policy

Booth selection, payment in full, and this signed Agreement must be submitted in the online exhibit portal unless otherwise arranged with NPA. Payment must be received by the due date specified in the Prospectus. If payment is not received by the due date, NPA reserves the right to revoke Exhibitor's exhibit privileges.

Exhibit booth space cancellations must be made in writing and will be honored with a refund until the cancellation date specified in the Prospectus, less a \$500 administration fee. Cancellations received after the cancellation date will not be refunded.

No Shows

Exhibitors with reserved exhibit space, who do not inform NPA in writing of their inability to exhibit prior to the Exhibit Hall opening, will forfeit all payments for booth rental and may not be eligible to exhibit at future NPA conferences.

Cancellation or Rescheduling of Conference

If NPA decides to cancel or reschedule the conference for any reason, the contract for exhibit space will be terminated. NPA will not be liable for damages sustained by Exhibitor resulting from such cancellation or rescheduling, and Exhibitor expressly releases NPA from claims for damages arising from such cancellation or rescheduling. NPA's sole obligation to Exhibitor shall be to refund the exhibit fee.

Use of Exhibit Space and Conduct

The general rule of the Exhibit Hall is "be a good neighbor." Booths must be staffed during exhibit hours. No exhibits will be permitted to interfere with the use of other exhibits or impede access or the free use of the aisle. Booth personnel are required to confine their activities within Exhibitor's booth space. Exhibitor is prohibited from marketing outside of the Exhibitor's booth space in the Exhibit Hall, unless prior written consent is received from NPA.

Exhibitor representatives shall conduct themselves in a professional and businesslike manner during conference hours and at affiliate events outside of NPA official conference hours.

Health, Fire Regulations and Public Safety

To ensure the safety of all participants, local fire regulations must be observed. All display materials must be flame-proof, and electrical signs and equipment must be wired to meet the specifications of local fire regulations. Exhibitor is charged with knowledge of and compliance with all laws, ordinances and regulations pertaining to health, fire prevention and public safety while exhibiting.

Care of Exhibit Space

All exhibits must comply with the IAEE Guidelines for Display Rules and Regulations. Exhibitors who fail to comply will be fined a minimum of \$250 per infraction by NPA.

Cost for repairing any damage to the Exhibit Space by Exhibitor or Exhibitor representatives shall be billed to and payable by the responsible Exhibitor. Nothing may be posted, tacked, nailed, screwed, or otherwise attached to the columns, walls, floors, ceiling, furniture or other property of the Exhibit Space or hotel.

Insurance and Indemnification

Exhibitors shall maintain insurance to cover damage or loss to exhibit materials and liability insurance to cover injury to persons, personal effects, and property of others in amounts consistent with industry standards. NPA may contract with security personnel at certain conferences during exhibit and non-exhibit hours, but Exhibitor remains solely responsible for the security of its exhibit booth and its exhibit materials during transit. Exhibitors are advised to use locked storage facilities within their own display area for excess merchandise.

Each party agrees to indemnify and hold harmless the other from any claims, damages or liabilities arising under this Agreement from its own acts, omissions or breach.

Changes to Terms

NPA reserves the right to make changes to these Terms in its sole discretion and will advise Exhibitors in writing of any changes or additions to the Terms. Any matters not specifically covered herein shall be determined by NPA in its sole discretion.

Exhibitor Responsibilities

Exhibitor agrees to use NPA's name or logo only with prior written approval and solely to identify the exhibitor relationship. Exhibitor shall avoid implying that NPA endorses or promotes Exhibitor's products, services or viewpoints.

Independent Parties

The relationship created by this Agreement is that of independent parties. Nothing herein shall be construed as creating an agency, partnership or joint venture.

Governing Law

This Agreement shall be governed by the laws of the Commonwealth of Virginia.

Exhibitor agrees to abide by the Terms set forth herein. If Exhibitor violates any of the Terms set by NPA, then NPA may terminate this contract in its sole discretion.

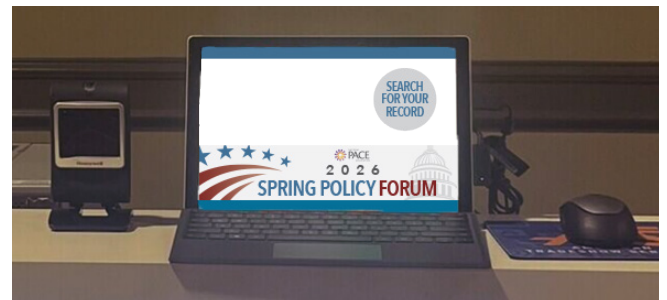
