Access to PACE

Definitions

- » Uses a Standardized Assessment Instrument for Eligibility Determination: This indicates whether the state requires a uniform assessment tool while determining eligibility.
- » Who Completes Initial State Standardized Assessments: This indicates whether the PACE organization, the county, the state or a third party conducts the initial level-of-care assessment.
- » Average Time for Level-of-Care Determination: This indicates, on average, how long it takes to review a level-of-care assessment and make a determination.
